ACTIVITY REPORT Academic year 2020/2021

1. 33rd AEHT Annual Conference – first AEHT online Conference

1.1. General aspects and content

The Annual Conference is the AEHT's flagship event and is held once a year in a different country; the programme includes meetings of the Presidium, the Executive Board and the General Assembly, as well as a series of contests, which enable students to compete in a variety of disciplines in multicultural teams thus subscribing to the values of EU.

Main goal of the AEHT Annual Conferences is thus promoting European values accepting divergence, multiculturalism and teamwork in hospitality and tourism industry, among other things:

- Giving insight into competences, professionalism, skills and careers in tourism;
- Upgrading image and professionalism of hospitality and tourism education in Europe;
- Encouraging contacts between schools around Europe;
- Promoting familiarization with European education systems;
- Exchange of good practice between teachers and students;
- Sharing teaching methods, materials, skills and knowledge.

The Annual Conference in 2020 was initially planned in Aveiro, Portugal, but had to be cancelled due to the pandemic. The Presidium decided to take over the organization with a reduced version, by going virtual with all official meetings mentioned above as well as the academic session intended for school principals, managers and teachers. Could also take place three competitions from the range of competitions normally held for students during this event, notably the front office, the tourism destination and the hotel management competitions. All other more practically oriented competitions were not retained as they would have been too complicated to organize in the remaining short lapse of time. However, to ensure the quality of the organization, the conference was postponed by one month by the Presidium, until early December, instead of the initially planned November.

Organizing the 33rd AEHT Annual Conference was a great challenge for the AEHT Presidium, who expresses its sincere thanks to the IT team from Turismo de Portugal as well as to Head Judges in charge of arranging the three competitions:

- Asdis Vatnsdal for the Tourist Destination competition
- Emil Juvan for the Front Office competition
- Paulo Vaz and Theo Verkoyen for the Hospitality Management competition.

Our thanks go also to all stakeholders involved in the Academic Program (see below). Without their valuable contribution the success of this first online AEHT conference would have been compromised.

The **Academic program** of Wednesday December 2nd had several parts:

Part 1: 14:00 -14:50: plenary part - festive opening of the meeting, presentation of the current situation of educational activities at partner schools by Tanja Angleitner Sagadin followed by a keynote address by Carlos Diez de la Lastra.

Part 2: 15:00 -16:45: Three parallel workshops, focused on identified challenges

Preliminary remark: Workshop 1 had to be cancelled shortly before the event due to the withdrawal of one of the moderators who had to replace a colleague affected by Covid19.

Workshop 1: Teaching culinary arts the hybrid way

The workshop should have been led by Marcus Hallgren (SE), Head judge of Decathlon, assisted by Mojca Polak (SI). Sweden and Slovenia represented two most opposing educational approaches in Covid19 times. While Sweden still had its schools open, Slovenia went entirely online with the whole educational process 6 weeks before the invitation to the workshop was sent out. The workshop should have addressed various

challenges in online and hybrid teaching approaches, focusing on cases of good practice, provided from the group. All culinary skills / cooking teachers had been invited to contribute to the discussion and debate. However due to its cancellation, the audiences of workshops 1 and 2 were combined.

Workshop 2: Challenges of hybrid delivery in the service and restaurant sector

This workshop was led by two head-judges, Thomas Gasteiner (AT) and Guillaume Staquet (FR). While Austria and France still had a chance to invite students to schools in smaller groups for hands-on learning experience, many countries had to implement ad-hoc online solutions for teaching service and restaurant skills. This workshop was aimed at service / restaurant / bar / barista / sommeliers and other F&B skills teachers, to exchange good practices.

<u>Workshop 3</u>: Creative online classroom: changed modalities and challenging online examination This workshop was led by Tanja Angleitner Sagadin (SI). Vocational schools and colleges throughout the AEHT network had one thing in common: learning by doing, learning from hands-on experience, enjoying the privilege of learning things in LIVE environment and profiting from specialized classrooms and coach-in-the moment teaching approach until Covid19 arrived, and turned the vocational education for many upside down. The workshop addressed the issue of assessing knowledge, organizing examinations in these changed times, changing modalities of delivery to make "staring into the screen for hours each day" more interesting. Several school directors and general subject teachers shared their online and hybrid teaching approaches, policies, and strategies with the audience.

Organizers are sure that this conference was essential to keep in touch with its members, prepare them to travel again in view of their involvement in 2021 in international activities, events and projects of the AEHT.

2. Head judges' working group

In 2013, for the 25th AEHT Anniversary Annual Conference on the cruise ship, the organisational guidelines committee had been replaced by a head judges working group bringing together all head judges of the competitions taking place during the Annual Conference.

Since then, the head judges used to meet several months prior to the Conference to inspect the venue/facilities of the forthcoming competitions and to set up the programme and the official guidelines with the organizing team. This way competition documents are earlier available to the participating schools, allowing them to prepare well in advance for the various competitions.

In spring 2020, due to the pandemic, the Presidium had however to take a difficult decision with the substitution of the Annual on-site Conference in Aveiro by a virtual one, that could only host three out of the ten competitions organized in normal times, leaving seven head judges without assignment. The Head judges on duty in 2020 were those responsible for the Front Office, Tourism Destination and Hospitality Management competitions (see hereafter:

Since March 2021 the AEHT Presidium is also able to count on the services of Ronny Thill, teacher at Luxembourg Hotel and Tourism School and long-time Head Judge for the Pastry competition at Annual Conferences. He is currently trained by Nadine Schintgen to take over her duties after her departure in November 2021.

7. Elections of National Representatives

In April 2021 the AEHT Head Office launched the process of electing national representatives by calling for applications in each member country of the Council of Europe. In most countries we received only one candidacy, and only in two countries, namely Croatia and France, it was necessary to organise an online ballot.

As for some countries no applications had been received, the AEHT Head Office undertook mid-June to contact all member schools in the relevant countries to fill the vacancy.

The process took longer than expected and, the results of the elections were not available until September, which delayed the second phase of the electoral process by several months, namely the call for candidates for the election of the new Presidium, which will be elected for a four-year term, from among the newly appointed National Representatives, at the next Executive Board meeting in Tallinn.

10. AEHT database and publications

10.1. AEHT database

On July 1st, the AEHT reckons some 300 member accounts in its database. This number includes active (264) and inactive (28) accounts. The later are accounts of new members that got accepted but have not yet paid their annual subscription and entrance fees. Besides, there are in total 8 professional member and privileged professional partner accounts.

The AEHT database allows member schools to register directly for the AEHT Annual Conference and also school account managers to include contact details of all colleagues interested in AEHT activities, in particular of the director and the AEHT contact person, thus enabling them to receive automatically all official mailings sent out by the AEHT Head Office. However, for the system to work properly, it is necessary for each school to check at least once a year all the data contained in its account and to update any data that have changed! This task, which used to be carried out by the AEHT Head Office, is now under the responsibility of each school.

10.2. Use of Office 365

According to Ahti Paju, the AEHT webmaster, there are many other platforms the AEHT could have used, but Office 365 offers, with one single account, a lot of interrelated platforms and various efficient tools (mail server, SharePoint, Online Office application, One Drive for Business - 1000 GB by user, Skype Business, Microsoft teams), that will make working together much easier and more efficient. Using Office 365 will take fewer operations to handle documents and allow several people to work on the same document. Besides, this platform is much more secure and supports many languages (training material exists in almost all EU languages). Moreover, for the AEHT, Office 365 Education is free of charge and its license is unlimited.

For all these reasons, the AEHT officials decided at the beginning of 2017 to use the Office 365 platform to be able to continue to offer professional and efficient services to the AEHT community, while keeping up with modern IT developments. It was agreed that the implementation would be carried out in several stages.

The first two steps have already been accomplished:

- 1st step: implementation of Office 365 by the AEHT Head Office during the 2nd semester of 2017
- 2nd step: implementation of Office 365 by all Presidium members beginning of 2018.

We have now started the 3rd phase, where all Head Judges and members of the Executive Board will be required to make use of it.

10.3. AEHT electronic newsletters and AEHT promotional brochure


Since End 2018, all AEHT newsletters are produced by means of the web-based presentation application Sway, which is part of the services offered by Office 365 and enables to combine text and media for more attractive online newsletters. Due to the pandemic, only one AEHT newsletter could be issued during the period 2020/2021 and published in September 2020 on the AEHT website (www.aeht.eu) and Facebook account.


Regarding the new brochure outlining the many benefits of AEHT membership published in March 2020, was dispatched to all National Representatives at the end of March 2021, with the request to forward it to their national members and to all potential school and professional members. The brochure is complemented by a flyer containing information on the current composition of the Presidium and a list of all the Annual Conferences held so far. As this information evolves over time, it is likely to be reissued whenever major changes occur.

10.4. AEHT Facebook account

The Facebook page is available at the following address: https://www.facebook.com/aeht.eu and was followed on August 1st, 2021 by 3200 persons, which represents an increase of 0,85 % compared to End July 2020 (3173 followers).

The total number of 'likes' rouse by 66 units (2,12 %) in one year; from 3119 likes on July 30th, 2020 to 3185 likes on August 1st, 2021, which is fine given the particular circumstances created by the pandemic.






10.5. AEHT website (www.aeht.eu)

During the first semester of 2016, a new website had been put online by the AEHT webmaster, Ahti Paju, together with Klaus Enengl and Neeme Rand, both Vice presidents at that time. As the use of mobile phones (smartphones) and tablet computers had increased significantly, the IT team of the AEHT had created a platform facilitating access to the site from these media. This platform is now fully operational for several years.


Below you will find an overview of the characteristics of the website audience between 1st August 2020 and 31st July 2021.

In brief, within the last academic year and, in comparison, with the previous year, the audience has dropped by 24,2 % from 23.041 to 17.469 users, the number of sessions by 23,7 % from 28.780 to 21.965 and the page views by 20,8 % from 52.433 to 41.521 pages. The graphic below shows that most traffic is reached on the AEHT web site during the first months of the academic year matching with the preparatory periods of the Annual conference and, usually, also of the Christmas in Europe event. In view of the cancellation of the latter, there was an exceptional drop in the audience after the end of the online congress in 2020.

11. Electronic communication

Over the course of the academic year 2020/2021, the AEHT Head Office has sent fewer official mailings (around 45) to members than in the years before the pandemic (around 60), due to the many postponements and cancellations of face-to-face events planned by our member schools.

12. Erasmus Plus Programme

The report for Erasmus Plus project no. **2019-2-LU01-KA105-050159**, which was set up to co-finance the Christmas in Europe event held in December 2019 in Barcelona (ES), was finally approved on November 24th, 2020, following the submission of additional documents to ANEFORE, the Erasmus Plus Agency in Luxembourg, and the balance of the grant was transferred to the AEHT on the same day.

While, due to the pandemic, the project in preparation with the Waterford Institute of Technology to cofinance the 2020 edition of Christmas in Europe had to be abandoned midway, the edition is being rescheduled for 2021 in Waterford (IE), during the famous Winterval, Ireland's major Christmas festival, hosting more than 30 events and over 300,000 visitors. This time, Vice President Ray Cullen and Secretary General Nadine Schintgen worked closely together to ensure the submission of the project for EU co-financing before the deadline of May 18th, 2021. The project proposal (no. **2021-1-LU01-KA152-YOU-000037758**) was approved by ANEFORE on 15th July 2021. A preparatory meeting for the event will take place with most of the partners during the AEHT Annual Conference in Tallinn (EE).

The community grant represents a significant financial support for both the organizers and participants of the event, and we wish to thank the Luxembourg Agency ANEFORE for their support in the setting up of the project and the European Commission for the means put at our disposal to improve the organization of our Christmas in Europe events as well as to ease the participation of all AEHT member schools, even those with poor financial means.
