## 1. 29<sup>th</sup> AEHT Annual Conference in London (UK)

### 1.1. General aspects

The Annual Conference is the AEHT's flagship event and is held once a year in a different country; the programme includes meetings of the Presidium, the Executive Board and the General Assembly, as well as a series of contests, which enable students to compete with each other in a variety of disciplines.

The 29<sup>th</sup> Annual Conference of the AEHT was held in London between 23<sup>rd</sup>-28<sup>th</sup> of October in 2017 with the participation of 544 guests from 23 countries. The conference was hosted by Docklands Academy London (DAL), a higher education institution of tourism and hospitality with an English school, located in Canary Wharf, the financial hub of London, and working in collaboration with partner restaurants, TAS, HAZ and HAZEV group, which support the activities of the Academy in providing targeted work experience for students within the hospitality and tourism sector.

The Conference started with an opening ceremony with dances and music all over the world in the glamorous venue of Church House, the headquarters of the Church of England dating back to the 1880s and located next to the Palace of Westminster and Westminster Abbey, which are both World Heritage sites.

All participants stayed at the spectacular four-star Guomon Hotel at Tower Bridge, which is only a short walk from the historic World Heritage site of the Tower of London, the castle of Her Majesty's Royal Palace and Fortress.

The competitions were held in 10 categories on the premises of DAL and Redbridge College, a partner school which provided its excellent kitchens and venues for most competitions.

Master classes were held for both kitchen and non kitchen students and the organisers offered a variety of workshops on "Cocktail Making", "Wine Tasting", "Cognac Project", "Effective Teaching & Class Management" and "EU Funding". Significant number of participants attended the workshops. The workshop on EU Funding given jointly by the Principal, Aysegul Yesildaglar and the Academic Head, Murray Cooper, of DAL, subsequently yielded to implementation of joint projects between DAL and some member schools of AEHT. One good example was a project titled "General English and Teacher Training Programme with CLIL methodology for Teachers", which was successfully implemented by DAL as the host school and Istituto Superiore Magnaghi as the visiting school. The organisers believe that member schools should be increasingly encouraged to develop projects with respect to training and work placement between each other. The organisers also think that the future annual conferences should include activities or workshops to facilitate and develop this collaboration.

The organisers provided participants with Oyster cards, a travel card enabling them to use the public transport, the most efficient way of commuting in a city like London, and to see the main attractions, with a guide prepared by the organisers. Therefore, the participants had a chance to move around and enjoy London fully at their own pace without experiencing the hustle of the city. The organisers also arranged a boat tour taking the participants from the Hotel to the Opening Ceremony giving them the chance to see most of London on the first day of the Conference. The participants were also provided a cable ride allowing them to see remarkable landmarks and developments such as O2 Arena.

The Conference was mainly sponsored by the registration fees received from the participants; however, the partner restaurants of DAL, TAS HAZ and HAZEV restaurant group, sponsored meals at their venues and also at Redbridge College throughout the Conference. Alongside the partner restaurants of DAL, a number of local sponsors such as Redbridge College, Zenith

Hygiene Group, Shining Dance Academy, Emirates Airlines, Guoman Tower Hotel, Centre for Turkey Studies (CEFTUS), T-Vine, Drury as well as AEHT sponsors, Villeroy&Boch and Cognac Embassy, supported the Conference.

The Conference ended with a Gala Dinner, which lasted until the early hours of the morning. Most of the participants expressed their satisfaction with the Conference giving good and encouraging feedback to the organisers.

#### 4. 2016 Christmas in Europe

From 4<sup>th</sup> to 10 December 2016, the Institute IPSSEOA Buscemi of San Benedetto del Tronto located in the province of Ascoli Piceno, in the March region of Central Italy has hosted and organized the 25th edition of Christmas in Europe whose origins date back to 1992 in Kaisersberg (France). Each year, this flagship event of the AEHT allows for a multitude of facets to be shown thanks to the participation of schools arriving from all over Europe. For the 2016 edition, nearly hundred participants have participated in this beautiful Christmas in Europe event co-financed by the Erasmus+ programme of the European Union, devoted to the spirit of Christmas and organized according to four intangible principles:

- each school presents the regional gastronomic specialties of Christmas at a fair
- participates in a folkloric parade,
- prepares some delicacies for the European buffet
- and makes a performance at the cultural show.



The delegations came from 11 countries, namely from Armenia (1), Belgium (1), Croatia (1), Czech Republic (1) Spain (1), Italy (3), Latvia (1), Luxembourg (1), Continental Portugal (2) and the Azores (1), Slovenia (2), and, last but not least, Sweden (2) – that is a total of 17 schools with more than 95 headmasters, teachers and students (not counting those of the host school). And

indeed they were a fine bunch of delegates, representing the diversity of Europe in a spirit of friendship and festivity.

## 5. Observation periods for teachers

### **Observation periods with the PESTENA Hotels & Resorts group**

In substitution to the collaboration with STARWOOD Hotels, the AEHT has intensified its cooperation with the Portuguese hotel group PESTENA Hotels & Resorts by signing an agreement on May 17<sup>th</sup>, 2016 expanding the range of its observation periods for AEHT teachers to further regions.

The group, that has a total of 51 hotels in Europe, Africa, Brazil, Colombia, Venezuela and the United States, has offered to provide AEHT teachers with placements of one week to 10 days in October and November 2017 as well as between January and May 2018 in unities located throughout mainland Portugal, Madeira as well as in North and South Africa. It is planned to expand the program in the future to South America and other European countries. Further information will be as usual published on the AEHT website ([www.aeht.eu](http://www.aeht.eu)), as it became available. Enthusiasts, roll-up.

Travel expenses will be as usual born by the teachers participating in the programme, but the AEHT will reimburse up to €200 per person upon receipt and approval of the placement report; an administrative fee of €80 will however be deduced for most countries to cover organisational costs. Accommodation at the hotel and meals taken with the staff will, in this case, be provided free of charge by the host company.

## 8. AEHT database and publications

### 8.1. AEHT database

Currently (20.09.2017), the AEHT database counts 336 member school accounts. This number includes active (300) and inactive (36) accounts. The later are accounts of new members that have not yet paid their annual fees. Besides, there are 3 professional member accounts and 5 sponsor accounts.

What changed with the new database, which is operational since early 2014, is that member schools can use it to register directly to the AEHT Annual Conference. Furthermore, account managers can include contact information of several persons of their school. Each one of them will automatically receive all official emails sent by the AEHT Head Office. Every school is supposed to check its data at least once a year!

What also changes with this new system is that *member schools are now responsible for updating* their account information. Previously, this task was provided by the AEHT Head Office.

### 8.2. Use of Office 365

AEHT officials have decided in 2017 to switch to the Office 365 platform to stay professional and updated with the IT development of our times. The implementation will occur in several phases:

- 1<sup>st</sup> step: AEHT Head Office will start using Office 365 during the second semester of 2017.
- 2<sup>nd</sup> step: Beginning 2018, all Presidium members will start using it.
- 3<sup>rd</sup> step: From second half of 2018, all members of the Executive Board will be required to use it.

According to Ahti Paju, the AEHT web master, there are many other platforms, but Office 365 offers, with one single account, a lot of interrelated platforms and various efficient tools (mail server, SharePoint, Online Office application, One Drive for Business - 1000 GB by user, Skype Business, Microsoft teams), that will make work much easier and more efficient. Using Office

365 will take fewer operations to handle documents and allow several people to work on the same document. Moreover, this platform is much more secure and supports many languages (training material exists in almost all EU languages).

Moreover for the AEHT, Office 365 Education is free of charge and its licence is unlimited.

### 8.3. AEHT Newsletter

A total of three AEHT newsletters have been issued in the period 2016/2017 and published on the AEHT website ([www.aeht.eu](http://www.aeht.eu)) and Facebook account.

### 8.4. AEHT Facebook account



## 12. “Erasmus+” Programme

In 2017, the AEHT participated for the second time in Luxembourg in the contest ‘Jugendpreis (Youth award)’, this time in the ‘Erasmus + 2014 - 2016’ category with its project ‘Christmas in Europe 2015 - Made in Luxembourg’ (project No **2015-2-LU02-KA105-000161**). The project has been selected, but not awarded. The main aim of the ‘Jugendpreis’ consist in offering a showcase for promotion to the most significant and innovative transnational projects in the field of youth, which have had an impact on the local, regional or national community



The project proposal (No **2016-2-LU02-KA105-000248**) submitted on April 21st, 2016 at SNJ - Service National de la Jeunesse, the Luxembourg Agency at that time in charge of youth mobility projects within the “Erasmus+” programme, to obtain a EU co-funding for the Christmas in Europe event held in 2016 in San Benedetto del Tronto (IT) was approved mid-July 2016. A preparatory meeting for the event took place during the AEHT Annual Conference in London (UK).

The project itself was carried out according to the criteria of the programme and the requirements of the call for tender 2016, recommending the integration of disadvantaged young people (from a social, economic, medical, educational, cultural and / or geographical point of view) to the group, and the promotion of European citizenship and tolerance among young people by encouraging their socialization with a very divers group of students and their encounter with a very cosmopolitan population with different ways of life and customs.

This event has enjoyed great popularity and good coverage in several media (articles in newspapers, Internet sites and Facebook pages, aso.). The final project report was filed February 14<sup>th</sup>, 2017 with the Luxembourg Agency and was approved on March 2<sup>nd</sup>, 2017.

On April 5<sup>th</sup>, 2017, the General Secretary submitted a new proposal No **2017-2-LU01-KA105-023935** with the programme “Erasmus+” at the newly responsible Erasmus Plus Agency, Anefore, this time to co-finance the Christmas in Europe event taking place in December 2017 in Fatima (IPT).

On July 12<sup>th</sup>, 2017, the Agency informed the AEHT Head Office that the project had been refused. The reasons given by the evaluators, e.g. the irrelevance of the objectives of the project with those of the program, the requirement of adding further exchanges per year to the programme, etc., seem aberrant given the project's acceptance for the last six years and the number of participants involved. On the other hand, the evaluators require a greater involvement of the young people in the elaboration of the project and a better use of the Youthpass. The General Secretary has already contacted the program's technical assistants for

further explanations with a view to rewriting the project according to evaluators' suggestions and program selection criteria. A meeting will be soon scheduled.

The community grant represents a significant source of financial support both for the organizers and participants of the event and the AEHT officials will do their utmost to recover this source of funding.
